WELCOME/ ROLL CALL

DY 5 OCTOBER REPORTING

DY 5 October Reporting Corrections

- As most outcomes have reported Performance Year 1, most P4P outcomes will not be eligible to submit a correction through the October DY5 reporting template without prior approval from HHSC.
- As a reminder, the October DY5 reporting template will automatically allow corrections to prior reporting for P4R outcomes and P4P outcomes that have reported a baseline only, excluding outcomes reviewed by MSLC and outcomes that have a custom goal (P4P change to P4R due to small volume, Maintenance, HHSC Approved Alternate Achievement).
 - Providers should have let HHSC know of any outstanding interim corrections no later than **Wednesday, September 14th** so that they can try to review and approve any changes prior to releasing the October DY5 reporting template.

DY 5 October Reporting

- Similar to April DY5 reporting, all providers will submit a Category 3 template & certification for milestones related to reporting and achievement of Category 3 outcomes
- Providers will not make any selections or updates in the online reporting system. All providers must submit a Category 3 Reporting Template, even if not reporting for payment.
- Providers will use the online reporting system to report on Population Focused Priority Measures (DY5 milestones AM-3.x) and Stretch Activities (DY5 milestone PM-11).

DY 5 October Reporting

- Anchors, Providers, and IGT entities should now have access to the *Project Reporting Summary* under the "Reports" function on their home page's menu bar. A brief guide to the new *Project Reporting Summary*, as well as the *Uploaded Files Summary* was included with the last Anchor Update. This information will be included in the updated version of the DSRIP Online Reporting System User Guide for October DY5.

DY 5 October Reporting

TECHNICAL UPDATES

Compliance Monitoring

- The review of DY 3 Carry Forward and DY 4 metrics will run from May till the end of **September**.
- The next round of audits is scheduled to begin in November.
- With regard to outstanding Category 1 and 2 - Round 1 for projects where additional work was requested by HHSC – HHSC is finalizing the review of these projects and metrics.
- MSLC will be finalizing the Round 2 Category 1 and 2 and Round 1 Category 3 Performance review by September 30th.
- MSLC Category 3 performance reviews that are not completed by September 30th will continue into October, and will not be eligible to report performance in October DY5 until review is complete. MSLC estimates that they can complete any outstanding Category 3 performance reviews by the end of October if providers do not request additional extensions.

Category 3 Updates

- Alternate Achievement Requests should have been submitted by September 6th, along with responses to HHSC comments regarding the DY6 Participation Form.
- The Stretch Activity DY6 Selection template is due to the RHP 10 Mailbox by COB, September 27th, 2016.
- HHSC has completed reviews of Category 3 Interim corrections that were submitted to HHSC by August 11th and should have notified providers of approval or any needed follow up.
- HHSC has also completed reviews of PFPM Baseline templates that were submitted August 15th and should have notified providers of approval or any needed follow up.

DY 6 Reporting

- Core Component and Sustainability reporting may only be reported in October 2017.
- DY6A Total QPI and MLIU QPI reporting may occur once DY5 QPI metrics have been achieved or forfeited. A provider will have an opportunity to forfeit their DY5 QPI metric achievement in either April or October if the provider believes they will not be able to achieve DY5 QPI carry forward.
- DY6A Total QPI and Pay-for-Performance MLIU QPI achievement may be reported after DY5 QPI metrics have been achieved or forfeited and as soon as the DY6A milestone has been achieved. Pay-for-Reporting MLIU QPI achievement may be reported once DY5 QPI metrics have been achieved or forfeited, and once the provider has provided at least one encounter toward the DY6A MLIU QPI goal.

HHSC Website

WAIVER RENEWAL

UC Update and DY 6 Rules

- The UC study was submitted to CMS on August 31st and sent to providers on September 2nd. If you did not receive a copy of the UC study and would like to review it please send an email to the RHP 10 mailbox.
- HHSC continues to work to finalize the second set of DSRIP rules for adoption. HHSC anticipates that the adopted rules will be published in the *Texas Register* in October or November 2016.

Waiver Renewal Update

- The Health and Human Services Commission sent a letter to the Centers for Medicare and Medicaid Services (CMS) to facilitate discussions on the longer term extension of the Medicaid 1115 Demonstration Waiver.
- CMS has requested an initial high-level work plan for integration into managed care, which HHSC is developing and will share with stakeholders before formal submission to CMS. The work plan will specify that a subset of projects will be identified for integration into managed care that could be either continuing or replacement projects.
- HHSC has reviewed and provided feedback on the DY6 DSRIP Participation Templates. HHSC will remind anchors/providers in the feedback process that funds associated with projects that providers elect not to continue in DY 6 will not be available to providers in DY 6 – 10.

Waiver Renewal Update

- **September 30, 2016** - HHSC will approve or deny the additional information submitted in response to HHSC comments.
- **October 3, 2016** - Approved DY6 projects are effective.

Replacement Projects

- The timeline is dependent on HHSC guidance and approval of DY7-10 protocols.
- HHSC's current timeline is for submission of RHP Plans in June 2017 which will shift depending on CMS approval.
- Replacement projects would be part of the updated RHP Plan.
- HHSC's current timeline is to have an approved DY7-10 PFM and Planning Protocol by Spring 2017.
- HHSC has not determined valuation changes for DY7 onward. Depending on discussions with CMS on requirements for DY7-10, then HHSC will have additional proposals on any changes to valuation.
