WELCOME/ ROLL CALL

APRIL DY 5 REGIONAL REPORTING

Needs More Information and IGT Updates

- Providers should hear back on any NMIs by August 5th, 2016.
- July 15, 2016 – April reporting DY5 DSRIP payments processed for transferring hospitals and top 14 IGT Entities.
- July 29, 2016 - April reporting DY4 DSRIP payments processed for all providers and DY5 DSRIP payments processed for remaining providers that were not paid on July 15, 2016.

TECHNICAL UPDATES

Compliance Monitoring

- The review of DY 3 Carry Forward and DY 4 metrics will run from May till the end of August.
- For previous reviews communication regarding possible recoupments will come from HHSC (June) and providers will have an opportunity to respond prior to the initiation of a recoupment.

Category 3 Updates

- The Category 3 Interim Correction period is currently in progress. All corrections are due to HHSC by **Friday, July 29th**.
- The interim correction template is available on the HHSC website at <http://www.hhsc.state.tx.us/1115-Waiver-Guideline.shtml> in the Category 3 section.
- HHSC has released a document of Category 3 operational details for DY 6. Please be sure to read through this document in its entirety.
- HHSC has released an updated Category 3 Summary Workbook & Goal Calculator prior to the interim correction period. This update includes DY5 R1 reporting.

Category 3 Updates

- The Category 3 Summary Workbook has received the following updates from the prior version:
 - The "Category 3 Summary" tab has been updated to include April DY5 reporting, MSLC baseline reviews reported to HHSC as complete by 05/31/16, and DY6 goals for most outcomes. DY6 goals for IOS - Survey outcomes using Scenario 2 or Scenario 3 will show as "TBD" pending a final goal setting methodology. Interim correction eligibility, and anticipated October reporting eligibility are also included.
 - The "Goal Calculator" tab now includes DY6 goals and achievement calculations, following the methodology approved in the Transition Year section of the Program Funding and Mechanics (PFM) Protocol.
 - The "Goal Calculator" tab can now be used for both primary category 3 outcomes and Population Focused Priority Measure (PFPM) outcomes. In cases where a provider has a PFPM selected, the goal calculator tab will be applicable to the PFPM outcome only.

Category 3 Operational Details for DY 6

- HHSC updated the Category 3 Summary Work to reflect data reported in April DY5, and include PY3 goals for DY6 achievement milestones for most outcomes. For outcomes that are P4P in DY6, DY6 goals can be identified in the "reporting history" section of the Category 3 Summary tab, or the PFPM section of the Category 3 Summary tab.
- Milestone structure for DY6 is determined by the approved milestone structure for DYs 3 - 5.
- P4P outcomes will continue in DY6 as currently approved, including measure selection and approved subsets. Goals for DY6 will be set using the same baseline used for DY4 and DY5 goal setting.

WAIVER RENEWAL

Waiver Renewal Update

- The UC Study is underway with contractors with a planned completion date of August 2016. A Draft version of the study was sent to CMS on July 15th.
- CMS has requested an initial high-level work plan for integration into managed care, which HHSC is developing and will share with stakeholders before formal submission to CMS. The work plan will specify that a subset of projects will be identified for integration into managed care that could be either continuing or replacement projects.

DY 6 Transition Year Updates

- The draft questions for core component reporting milestone reporting are posted on the waiver website for provider feedback. Please submit any questions or feedback regarding these draft questions to TXHealthcareTransformation@hhsc.state.tx.us by **July 22, 2016.**
- HHSC posted an updated DSRIP Participation Template last week, which corrects an issue with calculating IGT for Category 3 outcomes on the DY6 IGT Information tab. If you have already completed the previous template, the updated template does not need to be used because the change does not impact provider entries. Please note that the DSRIP Participation Template is due to the RHP Mailbox (RHP_Region_10@jpshealth.org) on **July 19th at 5PM.**

Statewide Learning Collaborative

- The primary goal of the Summit for 2016 is to share outcome data and best practices from projects, highlight effective systems of care and discuss next steps as we look to the future of the 1115 Healthcare Transformation Waiver.
- HHSC will broadcast the conference online so that individuals not able to attend in-person can watch presentations and hear discussions.
- Every DSRIP performing provider will have an opportunity for at least one representative to attend in person. Performing providers with 10 - 19 active projects may send two representatives, and those with 20 or more projects are invited to send three.

Statewide Learning Collaborative Video and PowerPoint Submissions

- HHSC would particularly like to highlight the specific impact on the uninsured population and on those in the Medicaid program
- HHSC would like to gather information from hospitals and other providers in RHP10. Specifically, HHSC would like:
 1. Video submissions focusing on DSRIP outcomes. These video stories should be no more than 2 minutes. HHSC prefers not to have patient narrative stories. Videos should discuss a particular DSRIP project and its impact on the uninsured and/or Medicaid enrollees.
 2. For hospitals and other providers that do not have the capability of submitting a video, the other option is to submit two PowerPoint slides. The first slide should give a brief project description and the second slide should detail outcomes for the uninsured and/or those in the Medicaid program.
