

WELCOME/ ROLL CALL

DY 7 OCTOBER REPORTING

DY 7 October Reporting

- The Costs and Savings guidance document has been added to the DSRIP Online Reporting System.
- HHSC has posted separately Attachments A and B that are included in the guidance document. Providers requesting the use of Alternative Tools will need to fill out and submit Attachment B by December 3, 2018.
- Category D-HHSC will send PPE reports to providers during the first two weeks of September. Regional summaries should be posted on HHSC website around that time as well.
- Category D reporting for Physician Practices, Community Mental Health Centers and Local Health Departments will be posted during first two weeks of September as well.

DY 7 October Reporting

- Save the date for October DY7 reporting webinars to be held on Thursday, October 4th. General reporting information and Categories A, B & D will be covered in the morning from 10:00 - 11:30, and the Category C webinar will be in the afternoon from 1:30 - 3:30. HHSC will send out webinar log-in information to all providers as soon as it is available.
- In preparation for the October DY7 reporting period, if a provider needs to request access to the reporting system for additional staff, they should complete the RHP Contact Change Form, making sure to check the option for DSRIP Website (User) under "Location of Change," and submit it to the waiver mailbox at TXHealthcareTransformation@hhsc.state.tx.us.

DY 7 October Reporting- Category D

- HHSC will post Cat D reporting questions on the bulletin board this week.
- HHSC has additional clarification for hospital reporting on Patient Satisfaction. As stated in previous communication, the measurement period for reporting on Patient Satisfaction will be standardized starting with the October DY7 reporting period, during which providers will use measurement period 10/1/2016 - 9/30/2017 (DY6). In DY8, providers will report on 10/1/17 - 9/30/18 either in April or October depending on when they receive "Top-Box" response data for the reporting questions. Providers must use consistent methodology for reporting in DY7 and DY8.

WAIVER 2.0

Waiver 2.0 Category A

- The draft October DY7 Category A reporting questions that are planned for the Cat A reporting template are now available.
- October DY7 reporting for the Costs and Savings portion of Category A requires providers to answer questions in the DSRIP Online Reporting System such as which tool providers plan on using, whether the tool provider plans to use is one of the HHSC recommended tools, and whether or not the provider has received approval from HHSC to use an alternative tool.

Waiver 2.0 Category C

- HHSC has completed review of early reported baselines and has sent notification of baseline acceptance or additional information/TA needed.
- They will be working with providers that had measures marked as "flagged for TA" throughout September.
- HHSC has posted a Category C Summary document to the online reporting system bulletin board under the "Category C Baseline Reporting" section. This document contains the final selections including milestone structure and measurement periods for all Category C selections, and will be updated as modifications are approved through modification requests and technical assistance.

 HHSC has reorganized the DSRIP Online Reporting System Bulletin Board. In order to regroup the sections, previous posts had to be removed and reposted with a date of 8/21/18. These files were not revised. As part of this process, documents that were outdated or posted on the 1115 Waiver website were removed from the Bulletin Board.
